- 1. WELCOME AND CALL TO ORDER:** Mayor Gibbs called the meeting to order at 6:02 p.m.
- 2. ROLL CALL:** A quorum of the council was present (6).
- 3. PLEDGE OF ALLEGIANCE TO THE FLAG:** Mayor Gibbs led the Pledge of Allegiance to the Flag.

Vice Mayor Kouts offered the opening prayer.

- 4. COUNCIL VACANCY:** Conduct interviews of the prospective City Council seat vacancy candidates. The City Council may enter executive session to interview candidates. Interviews will be conducted in the following order and times: 6:10 p.m. - Diane C. Junion; 6:50 p.m. - Jeff Campbell; 7:30 p.m. - Arnold A. Lopez; and 8:10 p.m. - Steve McGaughey.

It was moved by Councilmember Attaway, seconded by Councilman Malloque and carried unanimously to enter executive session at 6:04:29 p.m. to interview candidates for the council seat position.

Councilman Seale made a motion to appoint Steve McGaughey to fill the council seat vacancy. The motion died for a lack of a second.

It was moved by Councilman Malloque, seconded by Councilmember Attaway, and carried unanimously to enter executive session at 8:29:57 p.m. to discuss Item 5.2, possible future lease or sublease negotiations with the Arizona Commerce Authority concerning airport land pursuant to Arizona Revised Statutes §38-431.03(A)(7).
