

ORDINANCE NO. O20-016

AN ORDINANCE OF THE CITY OF SAFFORD, GRAHAM COUNTY, ARIZONA
AMENDING CHAPTER 2.04 CITY COUNCIL, SECTION 2.04.090 REGULAR
COUNCIL MEETINGS AND 2.04.110 WORK SESSIONS.

WHEREAS, Chapter 2.04, Section 2.04.090 of the Municipal Code establishes the regular meeting of the Council, and;

WHEREAS, Chapter 2.04, Section 2.04.110 of the Municipal Code establishes the work session meeting of the Council, and;

WHEREAS, it is the desire of the Council to amend the meeting room for regular meetings and the schedule for holding work session meetings, and;

NOW THEREFORE BE IT RESOLVED, by the Mayor and City Council of the City of Safford, Graham County, Arizona, Chapter 2.04, City Council, Section 2.04.090 Regular Meetings and Section 2.04.110 Work Sessions of the Municipal Code is hereby amended as follows:

2.04.090 - Regular Council meetings


- A. Except for properly called executive sessions as permitted by state law, all regular meetings of the Council shall be open to the public.
- B. Regular meetings of the Council shall be held on the second **and fourth** Monday of each month, commencing at 6:00 p.m. All regular meetings of the Council shall be held in the **Phelps-Dodge Library Program** Room of the City Library unless otherwise posted. When the day fixed for any regular meeting of the Council falls upon a day designated by law as a legal holiday, such meeting shall be held at the same hour on the day preceding the holiday, unless another date and/or time is designated.
- C. Any meeting of the Council may be adjourned to a later date and time; provided, that no adjournment shall be for a longer period than until the next regular meeting of the Council.

2.04.110 – Work Sessions

~~The council shall hold a council work session on the fourth Monday of each month commencing at 6:00 p.m. which shall be held at the city annex building unless circumstances reflect a larger room. The council may meet informally in work sessions which shall be open to the general public. No call to the public shall be scheduled during work sessions.~~


The Council may convene work sessions to be held at the Library Program Room unless otherwise posted, at such times as it may be necessary, subject to the open meetings law. The business to be considered shall be stated in the notice, and no formal action shall be taken on any matter considered at a work session. Work sessions will be open to the general public.


