## **ORDINANCE NUMBER 14-002**

AN ORDINANCE OF THE CITY OF SAFFORD, GRAHAM COUNTY, ARIZONA, AMENDING TITLE 13 OF THE MUNICIPAL CODE BY MODIFYING CHAPTER 13.20 MUNICIPAL WATER SYSTEM; SECTION 13.20.020, INSTALLATION CHARGES

WHEREAS, Chapter 13.20, Municipal Water System, Section 13.20.020 establishes installation charges and requirements; and,

WHEREAS, certain provisions of Title 13 Public Services, Chapter 13.20 Municipal Water System, Section 13.20.020 Installation charges, require further clarification and modification; and,

**NOW THEREFORE BE IT RESOLVED**, by the Mayor and City Council of the City of Safford, Graham County, Arizona, that **Chapter 13.20.020 (D)** of the Municipal Code of the City of Safford as contained in Title 13, Municipal Water System, is amended as stated below.

D. All such service connections may require cross-connection control valves as specified by Arizona Department of Health Services, these valves shall be installed at the property line and the valves shall be tested by a certified tester. In addition, service connections may require pressure-reducing valves. The need for these valves will be determined by city staff. and installed by city. The required valves shall be paid by the person making application for such service. The applicant will pay city for all such costs at the time serve installation fee is paid.

## 13.20.020 Installation charges.

Installation charges shall be fixed by resolution of the city council consistent with the provisions of this section.

- A. The costs to applicants for service connections as provided in this section shall, in each case, be determined by price lists, open to the public, setting forth the unit prices for the respective materials and labor and conforming to the prevailing prices then locally current for such materials and labor.
- B. The cost of repairing or replacing any pavement or other structure necessarily damaged in the process or because of the installation of any service connection, either within or without the corporate limits of the city, shall be paid by the person making application for such service, in addition to any other charges that may be required for such service.
- C. The total cost of the installation and all costs incidental thereto for any private fire protection service shall be paid by the person making application for such service. Any service connection installed for private fire protection shall be used solely for such service and no other. The agreement incorporated in the application for such service shall contain the foregoing provision.
- D. All such service connections may require cross-connection control valves as specified by Arizona Department of Health Services, these valves shall be installed at the property line and the valves shall be tested by a certified tester. In addition, service connections may require pressure-reducing valves. The need for these valves will be determined by city staff.—and installed by city. The required valves shall be paid by the person making application for such service. The applicant will pay city for all such costs at the time service installation fee is paid.
