

**RESOLUTION NO. R21-028**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SAFFORD, GRAHAM COUNTY, ARIZONA AUTHORIZING THE CITY MANAGER TO ACCEPT A GRANT FOR STATE FUNDS FROM THE ARIZONA DEPARTMENT OF TRANSPORTATION FOR THE PURPOSE OF AIDING IN FUNDING A PROJECT FOR A P-608 SURFACE APPLICATION AND PAVEMENT MARKINGS FOR RUNWAY 12/30 AT THE SAFFORD REGIONAL AIRPORT.**

**WHEREAS**, the City of Safford, Graham County, Arizona (City), owns and maintains the Safford Regional Airport; and

**WHEREAS**, the Arizona Department of Transportation Multimodal Planning (ADOT MPD) Aeronautics Group has completed the planning and program development phase of the State's Airport Pavement Preservation Program for fiscal year 2022; and

**WHEREAS**, Safford Regional Airport is included in fiscal year 2022 of the program for Runway 12/30, Section 10, P-608 Application and Pavement Markings with a construction estimate of \$391,610; and

**WHEREAS**, the Arizona Department of Transportation will pay 100% of the design and construction administration costs; and

**WHEREAS**, the City's matching funds for this project will be 10% of the final construction cost, estimated to be \$39,161; and

**WHEREAS**, the City of Safford desires to secure these funds for these improvements at the Safford Regional Airport, and;

**NOW THEREFORE BE IT RESOLVED**, by the Mayor and City Council of the City of Safford, pursuant to A.R.S. §28-8418 the City of Safford will participate in the State's Airport Pavement Preservation Program for fiscal year 2022 and accept funding for a project for a P-608 Surface Treatment Application and Pavement Markings for Runway 12/30 at the Safford Regional Airport.
